# CASE #2021-1072 Newman Land & Cattle Co. Inc., Owner Prestigious Pavers, Tenant

Location of Violation: 1320 Michigan Avenue, St. Cloud, Florida

Violation: St. Cloud City Code, sections 40-132 & 12-132 and Land Development

Code, section 3.19.10 (A,2)

**Description of Violation:** Failure to prohibit but rather allowed window signage without first obtaining a permit and not obtaining a Business Tax Receipt License or the Certificate of Use License for the business at this location.

# **CASE #2021-1913** Juan R. Illas, Owner

**Location of Violation**: 1406 Maryland Avenue, St. Cloud, Florida **Violation**: The St. Cloud City Code, Sections 24-52 (A) & 24-162 (A).

Description of Violation: Failure to prohibit but rather allowed abandoned vehicles and

high grass at this location.

# CASE #2021-2012 Xebec, Inc. / St. Cloud Apts. LTD, Owner

Location of Violation: 1701 Michigan Avenue, St. Cloud, Florida

**Violation:** The 2015 International Property Maintenance Code, Sections 102.2, 301.2, 304.2, 304.1.1 (8) and 304.6 adopted by St. Cloud City Code, Section 10-33 (A).

**Description of Violation:** Failure to prohibit but rather allowed the disrepair and maintenance of the exterior property areas at this multi-family apartment complex.

# CASE #2021-2076 Russell and Tabitha Alexander, Owners

Location of Violation: 725 Maryland Avenue, St. Cloud, Florida

**Violation:** The 2015 International Property Maintenance Code, Section 302.1 adopted by St. Cloud City Code, Section 10-33 (A) and St. Cloud City Code, Sections 24-52 (A) & 24-162 (A).

**Description of Violation:** Failure to prohibit but rather allowed high grass, abandoned vehicles and the exterior property areas to not being maintained in a clean, sanitary condition at this location by the time specified.

#### CASE #2021-2171 Northern Lights Investments LLC., Owner

Location of Violation: 1118 Massachusetts Avenue, St. Cloud, Florida

**Violation:** Land Development Code, sections 3.3.1 (F) & 13.3 and St. Cloud City Code, section 24-1.

**Description of Violation:** Failure to prohibit but rather allowed the demolition of the stairs prior to obtaining a permit and an unsightly condition at this location.
