BACKGROUND INFORMATION:

Personal estate columbarium has been requested by our residents. A personal estate columbarium is a private structure designed to be the final resting place for a loved ones cremated remains. The standalone unit is a luxury unit with its own alcove and private vase for flowers. They allow you the option to have your family name presented across the front archway, as well as individual or shared engraving added to the doors of the unit. These units are available in two options: a 2-door unit which allows up to 4 cremains, or a 4-door unit which allows up to 8 cremains. Our estate columbaria are secluded from the community columbaria and each unit will provide a 3 ½ foot extended concrete section to allow visiting loved ones a dedicated area to stand off of the main walking path. Site owners and their families will not have access to open the doors of the units and would be required to pay the \$100 open/close fee for each interment, this will ensure accurate recorded keeping of the individuals in each unit.

Staff is requesting approval of Resolution No. 2022-082R, by adopting the option of purchasing a two (2) door or four (4) door personal estate columbarium unit at Mt. Peace Cemetery.

The STOPR Group consisting of the City of St. Cloud, Toho Water Authority, Orange County, Polk County, and Reedy Creek Improvement District, entered into the Memorandum of Agreement for Cost Sharing and Permit Compliance Coordination (Agreement) in October 2007 following the joint issuance of each entity's individual Water Use Permit (WUP) by the South Florida Water Management District. The Agreement provides for the STOPR Group to contract for on-going services required implement, maintain, and routinely report on the monitoring program required as a permit condition for the STOPR Group's WUPs collectively. The Agreement has been amended periodically to incorporate changes and updates in the contracts for the monitoring and other related services. Amendment Seven consolidates the original Agreement, the subsequent six amendments, and this seventh amendment into an Amended Agreement. Within the Amended Agreement and this Seventh Amendment TOHO is authorized as Contract Manager to contract for additional engineering and field services for the STOPR Group groundwater level monitoring, groundwater quality monitoring, environmental monitoring, data management, compliance reporting, and other services required to achieve compliance with the respective WUPs and the Central Florida Water Initiative related services. The Seventh Amendment extends the term of the Amended Agreement to June 30, 2030 to cover the time up through the renewal of the WUPs in 2027 and the incorporation of potentially new monitoring requirements associated with the permit renewals. Exhibit H of the Seventh Amendment is the scope of work and related budgeted fee with the contractor, WSP, for the period July 1, 2022 through the term of the Amended Agreement. The City of St Cloud's share of the budgeted fee over the 8 year period is \$410,758.00 or approximately \$51,345.00 annually. Environmental Utilities has been budgeting \$100,000.00 annually previously to cover these expenses. The City's share is based on its proportionate share of the total of the STOPR WUPs water allocation at 10.8%. The Seventh Amendment also contains the authorization for the City Manager to execute any subsequent amendments to the Amended Agreement which are strictly limited to changes in the scope of services but do not provide for any increase in the approved budget or commit any of the parties to further expenditures beyond that approved in this

amendment. In summary this Seventh Amendment provides for the continuation of the STOPR Group WUP monitoring contracts and related services.
